- 18. SECTION 1. The Bishop Kemper School for Ministry (BKSM) is a jointly-owned
- 19. subsidiary of the Dioceses of West Missouri, Kansas, Western Kansas, Nebraska,
- 20. Missouri, and Iowa, incorporated in the State of Kansas, governed under its own By-
- 21. Laws, and operated for the mutual benefit of the six (6) dioceses.

- 23. SECTION 2. The Diocese of West Missouri is entitled to three (3) seats on BKSM's
- 24. Board of Directors. The Annual Convention shall elect the three (3) Directors one
- 25. layperson, one Deacon, and one Priest.

- 27. (a) Each Director shall serve a three-year term. The terms of Directors shall
